It supersedes all prior and simultaneous agreements between the parties. The only way to add or change this agreement is to do so in writing, signed by all the parties.

1) COMMISSION OF THE PHOTOGRAPHY SERVICE AND ITS DESCRIPTION: the client commission at the photographer a colours and black/white service for the weddings ceremony. If not specified the photographer chooses the photo that must be put in the album without the print of rough drafts. Instead if the client want to choose the photos is indispensable to print rough drafts at the price of ..... each. The service will be composed of ..... pages in a format of ..... The client has chosen the photographic album. The client commission the photographer also a wedding's video that will be realised by a photographer's collaborator that will consist in a DVD assembled (duration 30 minutes) with 3 copies, and 1 DVD of the video master with 1 copie, and HD.

2) PHOTOGRAPHER PAYEMENT: the client will pay photographer for the photo and video's service euro ..... Some transfer costs are not included in the price.

4) COMPLETION SCHEDULE: prints and video take about two months.

5) CANCELLATION: In the event of cancellation you have to cancel within 7 days. If:

a) The cancellation occurs within more than 60 days to the event the retainer is nonrefundable.

b) The cancellation occurs within 60 and 30 days to the event the photographer must have the 50% of the total amount.

c) The cancellation occurs within the thirty days prior to the event the client have to pay the entire amount.

6) COPYRIGHTS: the photographs produced by are protected by Federal Copyright Law (all rights reserved) and may not be reproduced in any manner without explicit written permission.

7) MODEL/EXHIBITIONS/RELEASE: photographer retains ownership of digital originals and the unrestricted right to copyright, use and publish images resulting from this assignment for commercial, promotion, competition or other purposes.

8) ADDITIONAL PRODUCTS: any additional products that are ordered later must be paid in full when that order is placed. The files photo and video are archived until 3 months.

9) LIMIT OF LIABILITY: In the unlikely event that the photographer is injured, becomes too ill to photograph the event, or cannot perform this agreement due to fire, casualty, nature, terror, or other cause beyond the control of the parties, the photographer will make every effort to secure a replacement photographer.

10) CONTROVERSIES: for any controversy the Foro of Sorrento is the competent organism.
